we're number one! Midway Shelter Honored For Highest Outcomes

t Alameda County's recent Achieving Outcomes Community Celebration on June 12, our Midway Shelter was lauded by Alameda County as its highest achieving shelter program for 2013!

The award reflects Midway's outcomes in terms of shelter residents linked to permanent housing. All of the County's 15 homeless shelters are ranked.

Why is this rate important? Because it means Midway residents end their homelessness while they are with us. Life skills groups, mental health and medical services, linkage to job training and public benefits, and school advocacy also help our residents build safe and stable futures.

Supportive Services for Veteran Families

orris and Yolanda Ridgeway are determined to help spread the word: Building Futures can help veterans overcome financial setbacks that threaten their housing.

Since 2011, Building Futures has served as a partner in the VA-funded Supportive Services for Veteran Families (SSVF) program. Along with helping vets avert homelessness or become quickly housed after homelessness,



the program also connects them with healthcare services, job training and budget planning, and helps pay for rent and transportation. Our partners in this effort are Abode Services, Operation Dignity, and Lifelong Medical Care.

The Ridgeways are both veterans (Torris of the Air Force; Yolanda served in the Army). The two dated briefly in high school. Both Torris and Yolanda served actively for ten years. Later, on a whim, Yolanda called Torris's parents to ask about him. Soon, the two were married.

After being discharged, Torris worked steadily as a mechanic and driver. "He's known as the neighborhood expert," Yolanda reports with pride. The two have raised two children together, Carena and William. Torris refers to the two as "golden." "Never so much as a call or letter from their schools," Yolanda adds. The teens are both looking ahead to attending college.

Torris, who served during Operation Desert Storm, says he was "embarrassed" to seek help after traveling to Baltimore to close out family affairs after his father's death caused him to lose his job. "I always worked, so I never needed anything from the VA," Torris says.

Today, both Yolanda and Torris are disabled. Yolanda relies on a walker for mobility. Torris walks with great difficulty. "The Ridgeways needed back rent and help with PG&E bills," says Building Futures' Case Manager, Yolanda Duran. Duran worked with the couple to fast track obtaining discharge papers, then to obtain the funds the family needed to keep their housing. "Because of this important program, the Ridgeways avoided homelessness," says Duran.

Torris and Yolanda say they hope other veterans will hear their story and be encouraged to call the program for help. "Anyone who enlists is willing to put their lives on the line," says Torris. "I feel like this assistance is a 'thank you' for being there."

HOUSING FIRST ENDS HOMELESSNESS

he Federal government recently made official a shift in its strategy to end homelessness. The new strategy focuses on housing assistance (mainly monetary aid to secure and maintain housing), rather than shelter. In most cases, ensuring that individuals and families are housed is the "best practice" and most efficient way to serve homeless people.

Building Futures adopted the Housing First model in 2007. This service model prioritizes housing for individuals and families who need it. Most who fall into homelessness do so after a personal crisis. Quick assistance to these folks—who only need a little help requires little from the system and taxpayers. Others require resources beyond housing. These individuals and families need housing first—and then resources to meet their other challenges.

- Rapid Re-housing. Soon after they have become homeless, the client is connected wit h assistance to become quickly re-housed.
- Homelessness Prevention assistance keeps individuals and families in danger of becoming homeless to keep their housing. (The Ridgeway family

in the story above benefited from this type of help.) Building Futures provides Rapid-Re-housing and Homelessness Prevention services; Clients receive security deposits, back rent and utilities, landlord advocacy and housing locator services to retain or secure housing.

 Permanent Supportive Housing combines housing and services to help people with very complex challenges live more stable, productive lives. Building Futures provides 30 units of permanent supportive housing at Bessie Coleman Court.

No one can live safely and stably without a place to call home. Building Futures meets the unique needs of all we serve, with a priority placed on ensuring they are housed. We are proud to incorporate best practices for helping these individuals and families. With the necessary funding, we can end homelessness in their lives and in our communities!
